THE LIUSBC IS PROUD TO ANNOUNCE LONG ISLAND'S MOST PRESTIGIOUS SENIOR EVENT; THE 2020 SANDY CATALANO SENIOR MASTERS. THIS ONE DAY SCRATCH TOURNAMENT WILL BE HOSTED BY AMF BABYLON ON SATURDAY, MARCH 7, 2020. THE CATALANO FAMILY AND THE LIUSBC WILL ADD \$2,000 TO THE PRIZE FUND MAKING THE SANDY CATALANO SENIOR MASTERS ONE OF THE RICHEST SENIOR SCRATCH TOURNAMENTS OF THE YEAR. SANDY CATALANO WAS A TALENTED BOWLER WHO DEDICATED A TREMENDOUS AMOUNT OF HIS TIME TO HIGH SCHOOL BOWLING. SANDY IS A MEMBER OF THE LIUSBC HALL OF FAME AND WAS INDUCTED DUE TO HIS BOWLING ACCOMPLISHMENTS AND THE TIME HE DEDICATED TO GIVING BACK TO THE GAME HE LOVED.

ENTRY FEE: THE COST TO ENTER THE SANDY CATALANO SENIOR MASTERS IS \$100 PER BOWLER. ENTRY BREAKDOWN: \$20 FOR LINEAGE, \$10 EXPENSES, \$70 PRIZE MONEY (100% RETURNED.) THE CATALANO FAMILY AND LIUSBC WILL BE ADDING \$2,000 TO THE PRIZE FUND.

HOW TO ENTER: IT IS RECOMMENDED BOWLERS PRE-PAY OR PRE-REGISTER AS **ENTRIES WILL BE CAPPED AT 96**. WALK-IN ENTRIES WILL BE ACCEPTED, ON A FIRST COME FIRST SERVED BASIS, IF SPACE IS AVAILABLE. ENTRIES CLOSE ON SATURDAY, MARCH 7, 2020 AT NOON OR WHEN THE 96TH PAID ENTRY IS RECEIVED. TO PRE-REGISTER OR PRE-PAY BOWLERS CAN: #1. ENTER ON-LINE AT WWW.LIUSBC.COM AND PAY WITH A CREDIT OR DEBIT CARD. ALL ON-LINE ENTRIES MUST BE COMPLETED NO LATER THAN 2 HOURS PRIOR TO THE START OF THE EVENT. ANYONE THAT FAILS TO BOWL, THAT HAD A PRE-PAID ENTRY, WILL FORFEIT THEIR ENTIRE ENTRY FEE UNLESS THE LIUSBC IS NOTIFIED PRIOR TO THE START OF THE EVENT. #2. CALL THE LIUSBC OFFICE AND PRE-REGISTER BY PHONE (631.737.0825) #3. MAIL THE ENTRY FORM WITH PAYMENT (MAKE CHECK PAYABLE TO LIUSBC) TO THE LIUSBC OFFICE, OR #4. WALK INTO AMF BABYLON AND PAY ON-SITE.

BOWLING BALLS: COMMITTEE RESERVES THE RIGHT TO CHECK BOWLING BALLS FOR CONFORMITY WITH USBC RULES. ALL NON-CONFORMING BALLS WILL BE RETAINED UNTIL THE CONCLUSION OF THE SQUAD. BOWLERS WILL BE ALLOWED A MAXIMUM OF FOUR BALLS ON THE RACK AT ANY ONE TIME. TO ADD AN ADDITIONAL BALL ONE MUST BE REMOVED. ALL EQUIPMENT MUST BE AT THE MATCH LANES.

ELIGIBILITY: ALL LIUSBC SANCTION BOWLERS AGE 50 AND OVER AS OF MARCH 7, 2020 ARE WELCOME TO PARTICIPATE. NON-SANCTION SENIOR BOWLERS THAT RESIDE IN NASSAU OR SUFFOLK COUNTY ARE WELCOMED TO BOWL AS LONG AS THEY PURCHASE A SANCTION CARD. PROOF OF RESIDENCE IN THE FORM OF A VALID NYS DRIVER'S LICENSE OR NYS PERSONAL ID CARD WITH A NASSAU OR SUFFOLK ADDRESS IS REQUIRED. NO OTHER FORM OF PROOF IS ACCEPTABLE. MEMBERS OF THE LONG ISLAND, SCWBA, AND ELIBA HALLS OF FAME, AS WELL AS PAST ASSOCIATION CHAMPIONS, MAY BOWL REGARDLESS OF CURRENT ADDRESS OR SANCTION. NYCUSBC BOWLERS ARE PERMITTED TO COMPETE IN ALL LIUSBC EVENTS INCLUDING THE SANDY CATALANO SENIOR MASTERS. IF A NYCUSBC BOWLERS IS NOT SANCTIONED IN AN LIUSBC LEAGUE THEY MUST PAY A LOCAL SANCTION FEE OF \$11 PLUS ENTRY FEE TO PARTICIPATE.

FORMAT: ON SATURDAY, MARCH 7, 2020 STARTING AT NOON ALL ENTRANTS WILL BOWL FIVE (5) GAMES ACROSS TEN (10) LANES. THERE WILL BE 3 QUALIFYING AGE DIVISIONS: 50-59/60-69/70+. SIXTEEN (16) BOWLERS WILL ADVANCE TO THE MATCH PLAY FINALS. THE # OF FINALISTS ADVANCING FROM EACH AGE DIVISION WILL BE PROPORTIONAL TO THE PERCENTAGE OF ENTRIES EACH AGE DIVISION REPRESENTS OF TOTAL ENTRIES. ALL 3 AGE DIVISIONS WILL BE REPRESENTED IN THE FINALS UNLESS A DIVISION HAS LESS THAN 5 ENTRIES. IF A DIVISION HAS LESS THAN 5 ENTRIES THE BOWLERS IN THAT DIVISION WILL BE MERGED WITH THE NEXT YOUNGER AGE DIVISION.

FINALS: LANES WILL BE RE-OILED PRIOR TO THE START OF THE MATCH PLAY FINALS. THIS WILL GIVE EVERYONE A 30 MINUTE BREAK AFTER QUALIFYING. THE FINALS WILL BE SINGLE ELIMINATION ONE GAME MATCHES WITH THE HIGH SCORE ADVANCING TO THE NEXT ROUND. PAIRINGS FOR FIRST ROUND MATCHES WILL BE BASED ON TOTAL QUALIFYING PIN FALL WITH ALL 3 DIVISIONS COMBINED (#1 WILL BOWL #16, #2 WILL BOWL #15, ETC.) IF ANY POSITION IS TIED, THE BOWLER WITH THE HIGHER SINGLE GAME WILL BE PLACED IN THE HIGHER POSITION. AFTER ROUND 1 THE MATCHES WILL BE BASED ON BRACKET POSITION WHICH WILL BE DISPLAYED ON-SITE. ANY MATCH THAT IS TIED WILL BE BROKEN BY A ONE BALL ROLL OFF. IT WILL TAKE 4 ROUNDS TO DETERMINE A CHAMPION.

SUBSTITUTION & TARDINESS: ONCE AN ENTRANT STARTS IN QUALIFYING OR MATCH GAMES THERE SHALL BE NO SUBSTITUTIONS. SHOULD AN ENTRANT BE LATE, SCORING WILL BEGIN IN THE FRAME BEING BOWLED ON THE DESIGNATED LANE. A CONTESTANT WHO FAILS TO APPEAR FOR A MATCH WILL LOSE BY FORFEIT.

DRESS CODE: MEN: FULL-LENGTH DRESS BUSINESS PANTS WITH COLLARED OR PBA STYLE CREW NECK SHIRT. **WOMEN:** DRESS SLACKS OR APPROPRIATE SKIRT WITH COLLARED OR PBA CREW NECK STYLE SHIRT OR BLOUSE. NO T-SHIRTS, TANK SHIRTS, TANK TOPS, SWEATS, JEANS, CARGO PANTS OR HATS PERMITTED. FAILURE TO ADHERE TO THE DRESS CODE WILL BE AN AUTOMATIC DISQUALIFICATION AND FOREITURE OF ENTRY FEE.

POSTPONEMENT: THE TOURNAMENT MANAGER, BRIAN ZIESIG, WILL BE THE SOLE JUDGE TO DETERMINE IF THE WEATHER IS TOO INCLEMENT TO BOWL AND TO POSTPONE BOWLING OF SCHEDULED EVENTS. IF A POSTPONEMENT IS NECESSARY IT WILL BE POSTED ON WWW.LIUSBC.COM.

LANE PATTERN: A USBC CHALLENGE COMPLIANT ORIGINAL KEGEL PATTERN WILL BE USED FOR THE EVENT. LANES WILL BE OILED PRIOR TO QUALIFYING AND BEFORE THE FIRST ROUND OF THE FINALS. THE LANE PATTERN WILL BE RELEASED ON MONDAY, MARCH 2, 2020 ON WWW.LIUSBC.COM. THERE WILL BE NO OFFICIAL PRACTICE SESSIONS PRIOR TO THE EVENT.

PRACTICE SESSION: THERE WILL BE A 10 MINUTE PRACTICE SESSION PRIOR TO QUALIFYING. BOWLERS MAY ONLY PRACTICE ON THEIR STARTING LANES.

SIDE ACTION: BRACKETS AND AN OPTIONAL HIGH GAME POT WILL BE OFFERED.

PHOTOS: PARTICIPANTS MUST ALLOW LIUSBC TO USE THEIR LIKENESS IN THE FORM OF PHOTO OR VIDEO IN THE PROMOTION OF THE EVENT.
