THE PRO SHOP TEAM INVITATIONAL RULES & REGULATIONS

ELIGIBILITY: THIS IS AN INVITATION ONLY EVENT. THE 16 PRO SHOPS THAT ADVERTISED IN THE 2020 LIUSBC CALENDAR ARE THE ONLY ONES PERMITTED TO ENTER A TEAM IN THE LIUSBC PRO SHOP INVITATIONAL. TEAM ROSTER MUST ONLY INCLUDE LIUSBC OR NYCUSBC SANCTION BOWLERS.

ENTRY FEE: THE COST TO ENTER THIS EVENT IS \$50 PER TEAM. THE ENTIRE \$50 WILL BE USED TO COVER LINEAGE FEES. THE PRIZE FUND (\$1,000 CASH PLUS 32 BOWLING PRODUCTS) WILL BE PROVIDED BY LIUSBC.

HOW TO ENTER: THIS EVENT IS AN INVITATION ONLY 4-PERSON TEAM TOURNAMENT. ONLY PRO SHOPS THAT ADVERTISED IN THE LIUSBC 2020 CALENDAR WILL BE INVITED. ALL 16 PRO SHOPS ARE REQUESTED TO PROVIDE THEIR TEAM LINE UP WITH SANCTION #'S AND AVERAGES NO LATER THAN APRIL 1, 2020. ANY 4 BOWLERS CAN MAKE UP A TEAM. TEAM ROSTER DOES NOT HAVE TO BE AFFILIATED OR WORK IN THE PRO SHOP. YOU CAN REGISTER ON-LINE AT WWW.LIUSBC.COM. YOU CAN MAIL IN THE ENTRY FORM ON THE FRONT OF THIS PAGE TO THE LIUSBC OFFICE. TEAMS ARE REQUESTED TO CHECK-IN AT LEAST 30 MINUTES PRIOR TO THE SCHEDULED SQUAD TIME (11:30AM.) ROSTER CHANGES WILL BE ALLOWED PRIOR TO COMPETITION.

FORMAT: ALL TEAMS WILL BOWL 3 GAMES ON THE SAME PAIR OF LANES. TEAM HANDICAP IS 80% OF 960. HIGHEST HANDICAP TEAM SERIES WILL BE DECLARED THE WINNER. ALL 16 PRO SHOPS ARE GUARANTEED TO EARN A PRIZE. THERE ARE NO FINALS. NO MORE THAN ONE PBA CARDHOLDER OR ONE COLLEGIATE BOWLER MAY BE ON THE SAME TEAM.

HANDICAP/MAXIMUM AVERAGES: BOWLERS MUST USE THEIR HIGHEST 2018-2019 AVERAGE OF 21 GAMES OR MORE TO DETERMINE HANDICAP. WINTER AVERAGES TAKE PRECEDENCE OVER SUMMER AVERAGES. IF AN ENTRANT DOES NOT HAVE A CERTIFIED AVERAGE FROM 2018-2019, THEY CAN USE A CURRENT AVERAGE OF 21 GAMES OR MORE IF THEY BRING PROOF OF THAT AVERAGE (CURRENT LEAGUE STANDING SHEET.) IF A BOWLER'S CURRENT AVERAGE IS MORE THAN 10 PINS HIGHER THAN THEIR PREVIOUS YEAR'S AVERAGE, THEY MUST INFORM THE TOURNAMENT CHAIRPERSON. THERE IS NO MAXIMUM AVERAGE FOR THIS EVENT. IF A BOWLER DOES NOT HAVE A SANCTION AVERAGE THE TOURNAMENT DIRECTOR WILL ASSIGN ONE FOR HANDICAPPING PURPOSES.

RULES & LANE OILING: USBC RULES WILL GOVERN THIS EVENT. LANES WILL BE STRIPPED AND OILED PRIOR TO BOWLING. THE HOUSE SHOT WILL BE USED. PARTICIPANTS MUST ALLOW LIUSBC TO USE THEIR LIKENESS IN THE FORM OF PHOTO OR VIDEO IN THE PROMOTION OF THE EVENT. THERE IS NO OFFICIAL DRESS CODE FOR THIS EVENT BUT PLEASE WEAR CLOTHING THAT WILL NOT BE DEEMED "OFFENSIVE." TOURNAMENT DIRECTOR RESERVES THE RIGHT TO ASK SOMEONE TO CHANGE APPAREL IF INAPPROPRIATE.
