## WELCOME TO THE 2021 ISLAND BOWLING SUPPLY MASTERS

THE LIUSBC IS PROUD TO PRESENT LONG ISLAND'S MOST PRESTIGIOUS EVENT: **THE 2021 ISLAND BOWLING SUPPLY MASTERS**. THIS 3 DAY SCRATCH TOURNAMENT WILL BE HOSTED BY AMF EAST MEADOW OCTOBER 22-24, 2021. ISLAND BOWLING SUPPLY WILL BE ADDING \$1,000 TO THE PRIZE FUND.

**ENTRY FEE:** THE COST TO ENTER THE **ISLAND BOWLING SUPPLY MASTERS** IS \$160 PER BOWLER. REENTRIES ARE NOT PERMITTED. ENTRY BREAKDOWN: \$32 FOR LINEAGE, \$10 EXPENSES, \$118 PRIZE MONEY (100% RETURNED). **IN ADDITION TO THE PRIZE MONEY FROM ENTRY FEES, ISLAND BOWLING SUPPLY WILL ADD \$1,000 DIRECTLY TO THE PRIZE FUND.**

**HOW TO ENTER:** IT IS RECOMMENDED BOWLERS PREPAY OR PRE-REGISTER AS ENTRIES WILL BE CAPPED AT 80 PER SQUAD. WALK IN ENTRIES WILL BE ACCEPTED, ON A FIRST COME FIRST SERVED BASIS. ENTRIES CLOSE AT THE START OF THE LAST QUALIFYING SQUAD (SATURDAY, OCTOBER 23<sup>RD</sup> 4PM). BOWLERS CAN PREPAY AND PRE-REGISTER ONLINE AT WWW.LIUSBC.COM OR BY MAILING AN ENTRY FORM AND CHECK (MADE OUT TO LIUSBC) TO THE LIUSBC OFFICE. THE ONLINE ENTRY MUST BE COMPLETED 2 HOURS PRIOR TO THE SQUAD YOU WANT TO BOWL. CREDIT CARD PAYMENT IS ACCEPTED ONLINE AND ONSITE. ALL ENTRIES PAID WITH A CHECK MUST BE RECEIVED AT THE LIUSBC OFFICE NO LATER THAN 7 DAYS PRIOR TO THE START OF THE TOURNAMENT. BOWLERS WISHING TO PRE-REGISTER MAY DO SO BY CALLING THE LIUSBC OFFICE: 631-737-0825. ENTRANTS THAT ARE NOT FULLY PAID ARE REQUIRED TO CHECK IN 1 HOUR BEFORE THEIR SQUAD TIME OR THE SPOT MAY BE RESOLD. ANY BOWLER THAT PREPAID THEIR ENTRY, AND DID NOT BOWL, WILL FORFEIT THEIR ENTIRE ENTRY FEE UNLESS THEY INFORM THE LIUSBC 2 HOURS PRIOR TO THEIR SQUAD.

**BOWLING BALLS:** COMMITTEE RESERVES THE RIGHT TO CHECK BOWLING BALLS FOR CONFORMITY WITH USBC RULES. ALL NON-CONFORMING BALLS WILL BE RETAINED UNTIL THE CONCLUSION OF THE SQUAD. BOWLERS WILL BE ALLOWED A MAXIMUM OF FOUR BALLS ON THE RACK AT ANY ONE TIME. TO ADD AN ADDITIONAL BALL ONE MUST BE REMOVED. ALL EQUIPMENT MUST BE AT THE MATCH LANES.

**ELIGIBILITY:** THIS TOURNAMENT IS OPEN TO ALL SANCTION LIUSBC AND NYCUSBC BOWLERS. A RESIDENT OF NASSAU AND SUFFOLK COUNTY WHO IS NOT SANCTIONED THIS SEASON MAY PURCHASE AN AFFILIATED CARD (\$25.00.) NYCUSBC BOWLERS THAT ARE NOT SANCTIONED WITH LIUSBC WILL BE REQUIRED TO PAY THE \$11 LOCAL SANCTION FEE TO PARTICIPATE. PROOF OF RESIDENCE FOR NON-SANCTION BOWLERS, IN THE FORM OF A VALID NYS DRIVER'S LICENSE OR NYS PERSONAL ID CARD WITH A NASSAU OR SUFFOLK ADDRESS IS REQUIRED. NO OTHER FORM OF PROOF IS ACCEPTABLE. MEMBERS OF THE LONG ISLAND, SCWBA, AND ELIBA HALLS OF FAME, AS WELL AS PAST ASSOCIATION CHAMPIONS, MAY BOWL REGARDLESS OF CURRENT ADDRESS OR SANCTION.

**FORMAT:** THE ISLAND BOWLING SUPPLY MASTERS NOW OFFERS 2 DIFFERENT QUALIFYING DAYS TO BETTER ACCOMMODATE OUR MEMBERS. THE FIRST QUALIFYING SQUAD OPTION IS FRIDAY, OCTOBER 22 AT 8PM AND THE LAST 2 QUALIFYING SQUADS ARE ON SATURDAY, OCTOBER 23 AT 11AM OR 3PM. A BOWLER MAY ONLY ENTER 1 SQUAD AS REENTRIES ARE NOT PERMITTED. ALL ENTRANTS WILL BOWL 6 GAMES ACROSS 12 LANES. TOP 8 SCRATCH SERIES EACH SQUAD PLUS NEXT HIGHEST 8 SCRATCH SERIES (32 TOTAL) FROM THE 3 SQUADS COMBINED WILL ADVANCE TO A DOUBLE ELIMINATION MATCH PLAY FINALS. IF THERE IS A TIE FOR 32<sup>ND</sup> POSITION THERE WILL BE A ONE GAME ROLL OFF TO BREAK THE TIE AT A TIME SET BY THE TOURNAMENT COMMITTEE. IF THE 32<sup>ND</sup> SPOT IS STILL TIED AFTER THE 1 GAME ROLL OFF A 1 BALL ROLL OFF WILL DETERMINE THE ADVANCER. **NEW! AFTER ALL 3 SQUADS ARE COMPLETED, AND THE 32 FINALISTS ARE DETERMINED, ADDITIONAL CASHERS WILL EARN \$160 USING A 1 IN 4 RATIO OF TOTAL ENTRIES.**

**FINALS:** FINALS WILL BE HELD ON SUNDAY, OCTOBER 24<sup>TH</sup> WITH THE FIRST ROUND SCHEDULED TO BEGIN AT 11AM. ALL FINALISTS ARE REQUIRED TO REPORT TO AMF EAST MEADOW NO LATER THAN 10AM FOR PICTURE TAKING AND A CONTINENTAL BREAKFAST. PAIRINGS FOR FIRST ROUND MATCHES WILL BE BASED ON TOTAL QUALIFYING PIN FALL. (#1 WILL BOWL #32, #2 WILL BOWL #31, ETC.) AFTER ROUND 1 THE MATCHES WILL BE BASED ON BRACKET POSITION WHICH WILL BE DISPLAYED ONSITE. IF ANY POSITION IS TIED, THE BOWLER WITH THE HIGHER SINGLE GAME WILL BE PLACED IN THE HIGHER POSITION. ALL FINAL MATCHES WILL BE ONE GAME WITH THE HIGH SCORE ADVANCING. A DOUBLE ELIMINATION FORMAT WILL BE USED. ANY MATCH THAT IS TIED WILL BE BROKEN USING A ONE BALL ROLL OFF. IT WILL TAKE EITHER 9 OR 10 ROUNDS TO DETERMINE A CHAMPION. FINALS SHOULD BE COMPLETED AROUND 4PM.

**SUBSTITUTION & TARDINESS:** ONCE AN ENTRANT STARTS IN QUALIFYING OR MATCH GAMES THERE SHALL BE NO SUBSTITUTIONS. SHOULD AN ENTRANT BE LATE FOR THE SQUAD STARTING TIME, SCORING WILL BEGIN IN THE FRAME BEING BOWLED ON THE DESIGNATED LANE. A CONTESTANT WHO IS LATE OR FAILS TO APPEAR FOR A MATCH WILL LOSE BY FORFEIT.

**DRESS CODE: MEN:** FULL-LENGTH DRESS BUSINESS PANTS WITH COLLARED OR PBA STYLE CREW NECK SHIRT. **WOMEN:** DRESS SLACKS OR APPROPRIATE SKIRT WITH COLLARED OR PBA CREW NECK STYLE SHIRT OR BLOUSE. NO T-SHIRTS, TANK SHIRTS, TANK TOPS, SWEATS, JEANS, CARGO PANTS OR HATS PERMITTED. FAILURE TO ADHERE TO THE DRESS CODE WILL BE AN AUTOMATIC DISQUALIFICATION AND FORFEITURE OF ENTRY FEE.

**POSTPONEMENT:** THE TOURNAMENT MANAGER, RICH THOMAS, WILL BE THE SOLE JUDGE TO DETERMINE IF THE WEATHER IS TOO INCLEMENT TO BOWL AND WILL POSTPONE BOWLING OF SCHEDULED EVENTS. IF A POSTPONEMENT IS NECESSARY IT WILL BE POSTED ON WWW.LIUSBC.COM. AT NO TIME, FOR ANY REASON, WILL INDIVIDUAL POSTPONEMENTS BE GRANTED FOR A SPECIFIC SQUAD OR MATCH. FAILURE TO APPEAR WILL RESULT IN FORFEITURE OF ENTRY FEE AND POSITION STANDING.

**LANE PATTERN:** A USBC SPORT COMPLIANT ORIGINAL KEGEL PATTERN WILL BE USED FOR THE EVENT. USBC SPORT COMPLIANT PATTERNS ARE 3 TO 1 RATIO OR LESS. LANES WILL BE REDRESSED AFTER EACH SQUAD AND PRIOR TO THE FIRST ROUND OF THE FINALS. THE LANE PATTERN FOR THE ISLAND BOWLING SUPPLY MASTERS WILL BE RELEASED MONDAY, OCTOBER 18, 2021, PRIOR TO THE START OF THE TOURNAMENT ON WWW.LIUSBC.COM. NO OFFICIAL PRACTICE SESSIONS WILL BE OFFERED.

**PRACTICE SESSION:** THERE WILL BE A 10 MINUTE PRACTICE SESSION PRIOR TO EACH QUALIFYING SQUAD. BOWLERS MAY PRACTICE ONLY ON THEIR STARTING LANES.

**SIDE ACTION:** BRACKETS AND AN OPTIONAL HIGH GAME POT WILL BE OFFERED DURING ALL 3 QUALIFYING SQUADS. A CALCUTTA WILL BE RUN SUNDAY MORNING, PRIOR TO THE FINALS, OCTOBER 24 AT 9:30AM.
