2025 MIXED DOUBLES & OVER/UNDER TOURNAMENTS
TWO TOURNAMENTS – ONE ROOF – ONE DATE

ELIGIBILITY: ALL LIUSBC, STATEN ISLAND USBC AND NYCUSBC BOWLERS ARE ELIGIBLE TO BOWL. NON-SANCTION BOWLERS THAT RESIDE IN NASSAU OR SUFFOLK COUNTIES ARE ALSO ELIGIBLE TO PARTICIPATE BUT WILL BE REQUIRED TO PURCHASE A SANCTION CARD (\$27.) PROOF OF RESIDENCE IN THE FORM OF A VALID NYS DRIVER'S LICENSE OR NYS PERSONAL ID WITH A NASSAU OR SUFFOLK ADDRESS IS REQUIRED. NO OTHER FORM OF PROOF WILL BE ACCEPTED. NYCUSBC AND STATEN ISLAND USBC BOWLERS WILL BE REQUIRED TO PURCHASE LOCAL SANCTION (\$11) IF NOT SANCTIONED WITH LIUSBC.

ENTRY FEE: THE COST TO ENTER EITHER TOURNAMENT IS \$90 PER TEAM. \$27/LINEAGE, \$6/EXPENSES AND \$57 WILL BE ALLOCATED TO PRIZE MONEY, WHICH WILL BE RETURNED 100%. IF A BOWLER WISHES TO ENTER WITH MULTIPLE PARTNERS, THE COST OF EACH ADDITIONAL ENTRY IS \$57 PER TEAM. **MAY NOT HAVE MORE THEN 3 PARTNERS.** OPTIONAL SCRATCH PRIZE FUND FOR EACH TOURNAMENT IS \$20 PER TEAM.

HOW TO ENTER: ALL ENTRANTS ARE REQUESTED TO PRE-PAY ONLINE AT WWW.LIUSBC.COM OR USE THE QR CODE TO ALLOW TOURNAMENT STAFF THE MOST LEAD TIME AS POSSIBLE. PLEASE ONLY PRE-PAY ONE ENTRY ONLINE, EVEN IF YOU WILL HAVE MULTIPLE PARTNERS. MULTIPLE PARTNERS WILL BE ADDED AT THE TOURNAMENT SITE. ENTRIES CAN ALSO BE MAILED TO THE LIUSBC OFFICE. ALL ENTRIES PAID BY CHECK MUST ARRIVE AT THE LIUSBC OFFICE NO LATER THAN 7 DAYS PRIOR TO THE EVENT. WALK-INS ON THE DAY OF THE TOURNAMENT ARE ACCEPTED, IF SPACE PERMITS.

FORMAT: EACH BOWLER WILL BOWL 3 GAMES ON THE SAME LANES USING HANDICAP OF **90% OF 460**. THE SCORES FROM BOTH SQUADS WILL BE COMBINED TO DETERMINE THE CHAMPION. PAYOUT WILL BE A 1:4 RATIO FOR EACH TOURNAMENT. ALL TIES WILL SPLIT PRIZE MONEY EQUALLY. YOU MAY CASH EACH TIME YOU ENTER WITH A DIFFERENT PARTNER BUT ONLY CASH ONCE WITH THE SAME PARTNER.

MIXED DOUBLES TEAM MAKE-UP: TEAMS WILL CONSIST OF ONE MALE AND ONE FEMALE BOWLER WITH A COMBINED AVERAGE NOT TO EXCEED 460. THERE WILL BE AN OPTIONAL SCRATCH PRIZE FUND USING THE SAME TEAM MAKE-UP RULES.

OVER/UNDER TEAM MAKE-UP: TEAMS WILL CONSIST OF ONE BOWLER OVER 50 AS OF 4/6/2025 AND ONE BOWLER UNDER 50 AS OF 4/6/2025 WITH A COMBINED AVERAGE NOT TO EXCEED 460. THERE WILL BE AN OPTIONAL SCRATCH PRIZE FUND USING THE SAME TEAM MAKE-UP RULES.

AVERAGE: BOWLERS MUST USE THEIR HIGHEST 2023-2024 AVERAGE OF 21 GAMES OR MORE. WINTER AVERAGES TAKE PRECEDENCE OVER SUMMER AVERAGES. IF AN ENTRANT DOES NOT HAVE A CERTIFIED AVERAGE FROM 2023-2024, THEY CAN USE A CURRENT AVERAGE OF 21 GAMES OR MORE IF THEY BRING PROOF OF THAT AVERAGE (**CURRENT STANDING SHEET**.) IF A BOWLER DOES NOT HAVE AN AVERAGE, THE TOURNAMENT CHAIRPERSON WILL ASSIGN AN AVERAGE. THE PRIZE FUND PAYOUT MAY BE DELAYED ALLOWING TIME TO VERIFY BOWLER AVERAGES. ALL ATTEMPTS WILL BE MADE TO VERIFY EVERYONES'S AVERAGES AT THE TOURNAMENT SITE. ALL MONIES WILL BE PAID BY CHECK WITHIN 30 DAYS OF THE TOURNAMENT.

RULES: USBC RULES WILL GOVERN THIS EVENT. USBC RULES 319(A), (C), (D), AND (E) WILL NOT APPLY FOR THIS EVENT. ENTRIES CLOSE AFTER THE START OF THE 4 PM SQUAD. **LANES WILL BE STRIPPED AND OILED PRIOR TO THE 1 PM SQUAD ONLY. A HOUSE SHOT WILL BE USED.** RESERVED SPOTS FOR PREPAID ENTRIES ONLY. LANE ASSIGNMENTS FOR CHECKED-IN BOWLERS WILL OCCUR 20 MINUTES BEFORE THE SQUAD BEGINS. THEREAFTER, LANES WILL BE ASSIGNED IN SEQUENCE.

PARTICIPANTS MUST ALLOW LIUSBC TO USE THEIR LIKENESS IN THE FORM OF PHOTO OR VIDEO IN THE PROMOTION OF THE EVENT. THERE IS NO OFFICIAL DRESS CODE FOR THIS EVENT BUT BOWLERS' MAY NOT WEAR ANYTHING THAT MAY BE DEEMED "OFFENSIVE." TOURNAMENT DIRECTOR HAS THE FINAL SAY ON ALL APPAREL ISSUES.
