WELCOME TO THE 2025 LIUSBC SENIOR MASTERS

THE LIUSBC IS PROUD TO ANNOUNCE LONG ISLAND'S MOST PRESTIGIOUS SENIOR EVENT, THE 2024/2025 SENIOR MASTERS.

THIS IS A ONE DAY SCRATCH TOURNAMENT.

ENTRY FEE: THE COST TO ENTER THE LIUSBC SENIOR MASTERS IS \$125 PER BOWLER. ENTRY BREAKDOWN: \$32 FOR LINEAGE, \$8 EXPENSES, \$80 PRIZE MONEY (100% RETURNED.) THE LIUSBC WILL BE DONATING ALL 50/50 AND RAFFLE MONEY COLLECTED TO BE ADDED TO THE PRIZE FUND. PAYOUT WILL BE 1:5.

HOW TO ENTER: IT IS RECOMMENDED BOWLERS PRE-PAY OR PRE-REGISTER. PRE-PAY FEE IS \$125. WALK-IN ENTRIES WILL BE ACCEPTED, ON A FIRST COME FIRST SERVED BASIS. **WALK IN ENTRY FEE IS \$140**. ADDITIONAL MONEY WILL GO TO THE PRIZE FUND. ENTRIES CLOSE ON SUNDAY, APRIL 27TH, 2025 AT 1 PM.

PRE-REGISTER OR PRE-PAY BOWLERS: ENTER ON-LINE AT WWW.LIUSBC.COM AND PAY WITH A CREDIT OR DEBIT CARD. ALL ON-LINE ENTRIES MUST BE BY APRIL 24TH, 2025. ANYONE THAT FAILS TO BOWL, THAT HAD A PRE-PAID ENTRY, WILL FORFEIT THEIR ENTIRE ENTRY FEE UNLESS THE LIUSBC IS NOTIFIED PRIOR TO THE START OF THE EVENT. ADDITIONAL WAYS TO PRE-REGISTER: CALL THE LIUSBC OFFICE AND PRE-REGISTER BY PHONE (631.737.0825) OR MAIL THE ENTRY FORM WITH PAYMENT (MAKE CHECK PAYABLE TO LIUSBC) TO THE LIUSBC OFFICE.

BOWLING BALLS: COMMITTEE RESERVES THE RIGHT TO CHECK BOWLING BALLS FOR CONFORMITY WITH USBC RULES. ALL NON-CONFORMING BALLS WILL BE RETAINED UNTIL THE CONCLUSION OF THE SQUAD. BOWLERS WILL BE ALLOWED A MAXIMUM OF THREE BALLS ON THE RACK AT ANY ONE TIME. TO ADD AN ADDITIONAL BALL ONE MUST BE REMOVED. ALL EQUIPMENT MUST BE AT THE MATCH LANES.

ELIGIBILITY: ALL LIUSBC, NYCUSBC AND STATEN ISLAND USBC SANCTION BOWLERS AGE 50 AND OVER AS OF APRIL 27TH, 2025 ARE WELCOME TO PARTICIPATE. NON-SANCTION SENIOR BOWLERS THAT RESIDE IN NASSAU OR SUFFOLK COUNTY ARE WELCOMED TO BOWL, AS LONG AS THEY PURCHASE A SANCTION CARD. PROOF OF RESIDENCE IN THE FORM OF A VALID NYS DRIVER'S LICENSE OR NYS PERSONAL ID CARD WITH A NASSAU OR SUFFOLK ADDRESS IS REQUIRED. NO OTHER FORM OF PROOF IS ACCEPTABLE. MEMBERS OF THE LONG ISLAND, SCWBA, AND ELIBA HALLS OF FAME, AS WELL AS PAST ASSOCIATION CHAMPIONS, MAY BOWL REGARDLESS OF CURRENT ADDRESS OR SANCTION. IF A NYCUSBC OR STATEN ISLAND USBC BOWLER IS NOT SANCTIONED IN AN LIUSBC LEAGUE THEY MUST PAY A LOCAL SANCTION FEE OF \$11. PLUS ENTRY FEE TO PARTICIPATE.

FORMAT: ON SUNDAY, APRIL 27TH, 2025, STARTING AT 1 PM. ALL ENTRANTS WILL BOWL FIVE (5) GAMES ACROSS TEN (10) LANES. THERE WILL BE 3 QUALIFYING AGE DIVISIONS: 50-59, 60-69, AND 70 & OVER. 1 IN 5 IN EACH DIVISION WILL ADVANCE OT THE FINALS, THE TOURNAMENT WILL ADVANCE AT-LARGE SCORES AS NEEDED TO MAINTAIN THE CASH RATIO. THESE WILL BE HIGHEST SCORES OUTSIDE THE CUT LINE IN ANY DIVISION. IF A DIVISION HAS LESS THEN 5 ENTRIES, THE BOWLERS IN THAT DIVISION WILL BE MERGED WITH THE NEXT YOUNGEST AGE DIVISION.

FINALS: THE FINALS WILL CONSIST OF ONE GAME SINGLE ELIMINATION MATCHES WITH THE HIGH SCORE ADVANCING TO THE NEXT ROUND. PAIRINGS FOR THE FIRST ROUND MATCHES WILL BE BASED ON TOTAL QUALIFYING PIN FALL WITH ALL 3 DIVISIONS COMBINED. ANY TIES FOR SEEDING WILL BE BROKEN BY THE HIGHER GAME IN QUALIFYING. BYES WIILL BE USED AS NECESSARY WITHIN THE BRACKET. ALL MATCHES IN THE FINALS WILL BEGIN ON THE LEFT LANE, WITH THE HIGHER SEED DETERMINING WHO STARTS THE MATCH. TIES IN THE FINALS WILL BE DECIDED BY A ONE BALL ROLL OFF WHERE THE HIGHER SEED WILL DETERMINE LANE CHOICE AND ORDER.

RE-RACKS: THERE WILL BE A LIMIT OF 2 RE-RACKS IN ANY GAME BOWLED IN THIS TOURNAMENT.

SUBSTITUTION &TARDINESS: ONCE AN ENTRANT STARTS IN QUALIFYING OR MATCH GAMES THERE SHALL BE NO SUBSTITUTIONS. SHOULD AN ENTRANT BE LATE, SCORING WILL BEGIN IN THE FRAME BEING BOWLED ON THE DESIGNATED LANE. A CONTESTANT WHO FAILS TO APPEAR FOR A MATCH WILL LOSE BY FORFEIT.

DRESS CODE: MEN: FULL-LENGTH DRESS BUSINESS PANTS OR JEANS WITH COLLARED OR PBA STYLE CREW NECK SHIRT. WOMEN: DRESS SLACKS, JEANS OR APPROPRIATE SKIRT/SKORT WITH COLLARED OR PBA CREW NECK STYLE SHIRT OR BLOUSE. NO T-SHIRTS, TANK SHIRTS, TANK TOPS, SWEATS, SHORTS OR HATS PERMITTED. FAILURE TO ADHERE TO THE DRESS CODE WILL BE AN AUTOMATIC DISQUALIFICATION AND FOREITURE OF ENTRY FEE.

POSTPONEMENT: THE TOURNAMENT DIRECTOR, ANTHONY MARTINEZ, WILL BE THE SOLE JUDGE TO DETERMINE IF THE WEATHER IS TOO INCLEMENT TO BOWL AND TO POSTPONE BOWLING OF SCHEDULED EVENTS. IF A POSTPONEMENT IS NECESSARY, IT WILL BE POSTED ON THE LONG ISLAND USBC FACEBOOK PAGE AND INSTAGRAM PAGE.

LANE PATTERN: A USBC CHALLENGE COMPLIANT KEGEL PATTERN WILL BEUSED FOR THE EVENT. LANES WILL REOILED PRIOR TO QUALIFYING. THE LANE PATTERN WILL BE RELEASED ON FRIDAY, APRIL 25TH, 2025 ON THE L.ONG ISLAND USBC FACEBOOK PAGE AND INSTAGRAM PAGE. THERE WILL BE NO OFFICIAL PRACTICE SESSIONS PRIOR TO THE EVENT.

PRACTICE SESSION: THERE WILL BE A 10-MINUTE PRACTICE SESSION PRIOR TO QUALIFYING. BOWLERS MAY ONLY PRACTICE ON THEIR STARTING LANES.

PHOTOS: PARTICIPANTS MUST ALLOW LIUSBC TO USE THEIR LIKENESS IN THE FORM OF PHOTO OR VIDEO IN THE PROMOTION OF THE EVENT.
